### PUBLIC NOTICE

The applicants filing International Applications under PCT at Indian Patent Office as receiving office and selecting Indian Patent Office as International Searching (ISA) and Examining Authority (IPEA), are hereby directed to remit the payment of the fees as prescribed in the attached fifth schedule, as amended in 2016 of the patent rules, except handling fees (to be deposited to IB) and Late payment fees(RO/IN), by online transfer to the account of the "Controller of Patents", maintained at Central Bank of India, mentioning the International application number, and submit the copy of the **corresponding CBR** against each International application at RO/IN, ISA/IN, IPEA/IN, as soon as the payment is made but not later than 5 working days. The fee in INR is required to be paid by online transfer through the online payment portal. The account of the "Controller of Patents", maintained at Central Bank of India is accessible through online portal.

Accordingly the Receiving Office (RO) shall discontinue receiving/accepting the payment in the demand drafts with respect to the ISA/IN, IPEA/IN fees with effect from 01/05/2017.
