New Delhi, the 31st December, 2018

No. 28/2018-Central Tax (Rate)

G.S.R. 1272(E).—In exercise of the powers conferred by sub-section (1) of section 11 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Central Government, on being satisfied that it is necessary in the public interest so to do, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of India, in the Ministry of Finance (Department of Revenue), No.12/2017- Central Tax (Rate), dated the 28th June, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), *vide* number G.S.R. 691(E), dated the 28th June, 2017, namely:—

In the said notification, -

(i) in the Table, -

(a) after serial number 21A and the entries relating thereto, the following serial number and entries shall be inserted, namely: -

(c) against serial number 34A, in the entry in column (3), after the letters and words “PSUs from the”, the words “banking companies and” shall be inserted;

(d) against serial number 66, for the entry in column (2), the following entry shall be substituted namely: -
“Heading 9992 or Heading 9963”;

(e) serial number 67 and the entries relating thereto, shall be omitted;

(f) after serial number 74 and the entries relating thereto, the following serial number and entries shall be inserted, namely: -

(ii) in paragraph 2, after clause (za), the following clause shall be inserted, namely: -

“(zaa) “financial institution” has the same meaning as assigned to it in clause (c) of section 45-I of the Reserve Bank of India Act, 1934 (2 of 1934).”.

2. This notification shall come into force on the 1st day of January, 2019.

सा.का.नि. 1273(अ).—केन्द्रीय माल एवं सेवाकर अधिनियम, 2017 (2017 का 12) की धारा 09 की उप धारा (3) के तहत प्रदत्त शक्तियों का प्रयोग करते हुए, केन्द्र सरकार, जीएसटी परिषद की सिफारिशों के आधार पर, एतद्वारा, भारत सरकार, वित्त मंत्रालय (राजस्व विभाग) की अधिसूचना संख्या 13/2017-केन्द्रीय कर (दर), दिनांक 28 जून, 2017 जिसे सा.का.नि. 692 (अ), दिनांक 28 जून, 2017 के तहत भारत के राजपत्र, असाधारण के भाग-II, खंड 3, उप-खंड (i) में प्रकाशित किया गया था, में और आगे भी निम्नलिखित संशोधन करती है, यथा:-

(क) क्रम संख्या 1 के समक्ष, कॉलम (2), मद (छ) के पश्चात निम्नलिखित परन्तुक को अंतःस्थापित किया जाएगा, यथा:-

“वशर्ते कि इस प्रविष्टि में निहित कोई भी बात ऐसे किसी माल परिवहन एजेंसी के द्वारा, सड़क मार्ग से गुड्स कैरिज में माल के परिवहन के रूप में -

(क) केन्द्र सरकार या राज्य सरकार या संघ राज्य क्षेत्र के विभाग या प्रतिष्ठान; या

(ख) स्थानीय प्राधिकरण; या

(ग) सरकारी एजेंसियों,

जिन्होंने केवल धारा 51 के अंतर्गत कर में कटौती किए जाने के लिए माल एवं सेवा कर अधिनियम, 2017 (2017 का 12) में पंजीकरण कराया हो और न कि माल या सेवाओं की कर वाली आपूर्ति करने के लिए, को प्रदान की जाने वाली सेवाओं पर लागू नहीं होगी।”;
