
**Subject: Amendment in import policy of Chlorotrifluoroethene (CTFE) under HS Code 2903 77 90 of Chapter 29 of ITC (HS), 2017 – Schedule – I (Import Policy).**

**S.O. (E):** In exercise of powers conferred by Section 3 of FT (D&R) Act, 1992, read with paragraph 1.02 and 2.01 of the Foreign Trade Policy, 2015-2020, as amended from time to time, the Central Government hereby amends the import policy of Chlorotrifluoroethene (CTFE) under HS Code 2903 77 90 of Chapter 29 of ITC (HS), 2017 – Schedule – I (Import Policy).

Exim Code	Item Description	Present Policy	Existing Policy Condition	Revised Policy Condition
2903 77 90	Other derivatives, perhalogenated only with fluorine and chlorine	Restricted	Import permitted as per Policy Condition 1 below	Import permitted as per Policy Condition 1 below. However, import of Chlorotrifluoroethene (CTFE) is 'Free'.

**Effect of the Notification:** Import policy of Chlorotrifluoroethene (CTFE) under HS Code 2903 77 90 of Chapter 29 of ITC (HS), 2017 – Schedule – I (Import Policy) is revised from 'Restricted' to 'Free' and reference to Policy Condition 1 is deleted in the case of "Chlorotrifluoroethene (CTFE)" only.
