## ORDER UNDER SECTION 144 Cr.P.C. (Amendment)

In continuation to this office Order No. BLS-PESHI-1(1)/96-20091-20211 dated 20.04.2020 and of even number dated 21-042020 and in compliance to the Orders of the Govt. of India, Ministry of Home Affairs, issued vide No. 40-3/2020-DM-I(A) dated 21-04-2020, another Order of even number dated 24-04- 2020 and in exercise of the powers vested in me under Section 144(5) of the Code of Criminal Procedure, 1973, I, Rajeshwar Goel, IAS, District Magistrate, District Bilaspur, H.P., do hereby order that:-

- 1. Under Item No. 1 of the Order dated 20-04-2020 relating to Commercial and private establishments:
  - (I) In addition to shops already permitted to be opened in relaxation of the curfew, the following shops, except barber shops, beauty parlours, hair salons, liquor vends, restaurants, hotels, cafés and eating joints, may also remain open during curfew relaxation hours in District Bilaspur:
  - (a) all shops registered under the Shops & Establishments Act, including shops in residential complexes and market complexes, except shops in multi-brand and single brand malls, outside the limits of Municipalities and Nagar Panchayats, with 50% strength of workers with wearing of masks and social distancing being mandatory;
  - (b) all shops, including neighborhood shops and standalone shops, shops in residential complexes, within the limits of Municipalities and Nagar Panchayats, registered under the Shops & Establishments Act, except shops in market complexes and multi-brand and single brand malls, with 50% strength of workers with wearing of masks and social distancing being mandatory;
  - (II) With effect from 27<sup>th</sup> April, 2020, all the permissible shops may remain open from 0900 hours to 1300 hours (09:00 AM to 01:00 PM). Movement of general public for accessing services of these shops shall be allowed during permissible timings of 09:00 AM to 01:00 PM subject to the condition that: (i) only one person of a family shall go out for this purpose and movement shall strictly be from house/ place of stay to the point of delivery of essential item/ service and back; (ii) all such movement shall be on foot to the nearest shop/store/bank branch and no vehicle shall be allowed; (iii) every person moving out shall use mask/ face-cover.

Under Item No. 4 of the Order dated 20-04-2020 (Agricultural and Horticultural activities), following shall also include:-

- (I) Facilities for export/ import such as Pack houses, inspection and treatment facilities for seeds and horticulture produce.
- (II) Research Establishments dealing with the agriculture and horticulture activities.

- (III) Inter and intra State movement of planting materials and honey bee colonies, honey and other beehive products.
- 4. Under Item No. 12 of the Order dated 20-04-2020; In respect of Industries/ Industrial establishments permitted to operate under the MHA Guidelines, the GM DIC Bilaspur shall be competent to issue passes for movement of persons within District Bilaspur, which may be required for operation of such permitted industries/ industrial establishments within the boundaries of District Bilaspur. Further, supply of essential goods shall also include food processing units such as bread factories, milk processing plants, flour mills, dal mills etc. located in urban areas.
- 5. Under Item No. 13 of the Order dated 20-04-2020; In respect of Departmental construction works permitted to be started/ resumed, the District Head of the concerned department, executing related work shall be competent to issue passes for the movement of persons, machineries/ vehicles within District Bilaspur, which may be required for operation of such permitted works/ schemes within the boundaries of District Bilaspur.
- 6. Under Item No. 14 of the Order dated 20-04-2020 in respect of the Forest Department, the following shall also be included:-
  - (I) Forestry plantation and related activities, including silviculture operations and further;
  - (a) DFO concerned shall be competent to issue passes for the movement of persons, equipment and material within District Bilaspur, which may be required for combating forest fires.
- (b) For works of construction permissible under MHA Guidelines relating to Soil Conservation Department and Forest Department, the SDSCO and the DFO respectively shall appoint COMPLIANCE OFFICERS to ensure enforcement of social distancing norms by all persons involved in the permissible activity at work site and ensure that the MHA Guidelines and the Orders of SDMA/DDMA issued from time to time are complied by all concerned in letter and spirit during execution of such works. Advance intimation regarding construction works should be given by the Department to the Incident Commander i.e. the SDM concerned. Any violation of social distancing norms or MHA Guidelines/SDMA or DDMA order (as modified from time to time) found during the conduct of the permissible activities shall make the COMPLIANCE SOFFICER liable for prosecution in addition to the actual violator(s).
  - 7. For General Public; movement of public on foot for morning walks within localities of residence shall be permissible between 05:30 AM to 07:00 AM, subject to the condition that wearing of masks and maintenance of social distancing shall be mandatory at all times. Urban and Panchayati Raj institutions shall make the parks & gardens sanitized for such users.

Passes for inter-District & intra-District movement of persons within the State shall be issued by the respective SDMs of District Bilaspur.

Any person contravening this order shall be liable for prosecution under Section 269,270 and 188 of IPC 1860.
