ORDER

In continuation of the Order No. F.2/07/2020/S.1/53 dated 15.04.2020 and in exercise of the powers conferred under section 22 of the Disaster Management Act 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, Govt. of NCT of Delhi, hereby orders the following amendments in the consolidated revised guidelines for strict implementation by all the Departments/ Autonomous Bodies/ Local Authorities of Delhi:

Modifications

In Sub-clause 1 (x), the term 'shopping complexes' is replaced with 'market complexes within the limits of municipal corporations and municipalities'.

Inclusions

Sub-clause (xiii) & (xiv) under Clause 14 on Commercial and private establishments:

(xiii) *All shops registered under the Shops and Establishment Act, including shops in residential complexes and market complexes, except shops in multi-brand and single brand malls, **outside the limits of municipal corporations and municipalities**, with 50% strength of workers with wearing of masks and social distancing being mandatory.*

(xiv) *All shops, including neighborhood shops and standalone shops, shops in residential complexes, **within the limits of municipal corporations and municipalities**, registered under the Shops and Establishment Act, except shops in market complexes and multi-brand and single brand malls, with 50% strength of workers with wearing of masks and social distancing being mandatory.*

In pursuance of order No. 40-3/2020-DM-I(A) dated 24.04.2020 of Ministry of Home Affairs, GOI, the above said activities shall be allowed to operate in letter and spirit in NCT of Delhi with immediate effect, subject to strict maintenance of social distancing and other prescribed COVID-19 protocols. The containment zones shall be outside the purview of these relaxations and shall be strictly regulated as per laid down SOP of Ministry of Health & Family Welfare, Govt. of India.

District Deputy Commissioners of Police shall ensure strict compliance of this order and bring this order to the knowledge of all field functionaries at ground level in Delhi for strict compliance without fail, while ensuring that the containment of COVID-19 disease remains the main & prime objective of the district administration.

The above activities shall be excluded from the purview of the order No.F.2/07/2020/S.1/64 dated 19.04.2020.
