The Government have issued orders in the reference seventh referred above to intensify the lock down measures in the Urban areas under the Disaster Management Act, 2005:

- To intensify the present lock down measure, a complete lock down will be implemented in the Corporation limits of Chennai, Coimbatore and Madurai from 26.4.2020 Sunday 6.00 A.M. to 29.4.2020 Wednesday 9.00 P.M.
- Complete lock down will also be implemented in Corporation limits of Salem and Tiruppur from 26.4.2020 Sunday 6.00 A.M. to 28.4.2020 Tuesday 9.00 P.M.

2. Soon after the complete lockdown period mentioned above is over, the District Collectors/Commissioner, Greater Chennai Corporation in respect of Chennai City are directed to implement the lockdown till 3<sup>rd</sup> May 2020 as ordered in the reference fourth above with the conditions stipulated in the Government order first referred above. Thus the lockdown will continue after the period of complete lockdown is over as per the conditions prevailing prior to 26.4.2020 till 3<sup>rd</sup> May 2020. All Collectors are further directed to intensify their efforts in containment zone management to prevent spread of disease.
