**ORDER UNDER SECTION 144 CR.P.C.**

Whereas vide order No.40-3/2020-DM-1(A), dated 24.03.2020, the Union Home Secretary, Ministry of Home Affairs, Government of India had issued an order under Section 10(2)(1) of Disaster Management Act, stipulating lockdown measures for containment of COVID-19 in the country.

Whereas the same order was extended vide letter dated 14.04.2020 to remain in force till 3<sup>rd</sup> May, 2020 all over the country.

Whereas the lockdown order was extended upto 17.05.2020 by Ministry of Home Affairs, Government of India vide order dated 01.05.2020 wherein various guidelines have been issued including directions to the local authorities to issue prohibitory orders for prohibition of movement of individuals, for all non-essential activities between 7 pm to 7 am.

Whereas, a meeting was held on 03-05-2020 under the chairmanship of H.E. Governor of Punjab and Administrator, U.T., Chandigarh wherein it was decided to lift the curfew order imposed on dated 23-03-2020 and to further issue lock down measures in accordance with the guidelines of the Ministry of Home Affairs, Govt. of India issued on dated 01-05-2020.

Whereas, in pursuance of meeting held above, a detailed order bearing No. 13180-HIII(5)/2020/4714 dated 03-05-2020 was issued by the Adviser to the Administrator, U.T., Chandigarh regarding lock down measures for Union Territory of Chandigarh in accordance with the guidelines of the Ministry of Home Affairs, Govt. of India issued on dated 01-05-2020. Apart from other guidelines, prohibition of movement of individuals, for all non-essential activities between 7:00 pm to 7:00 am is mentioned in the above said order of Adviser to the Administrator, U.T., Chandigarh

Whereas the office of undersigned has issued an order No.DM/MA/2020/7293 dated 23.03.2020 wherein a CURFEW was imposed in the District and in continuation of that order various orders (No.DM/MA/2020/7327 dated 23/03/2020, No.DM/MA/2020/7446 dated 27.03.2020, No. DM/MA/2020/7498 dated 29.03.2020, No. DM/MA/2020/8433 dated 22.04.2020) were issued.

The above mentioned previous orders shall not remain in force after coming into force of this order.


Now, therefore, I Mandip Singh Brar, District Magistrate, Union Territory Chandigarh in exercise of powers vested with me under section 144 of Cr. P.C. do hereby order that there shall be prohibition of movement of individuals, for all non-essentials activities between 7 pm to 7 am. Any breach of this order would invite action under section 188 of Indian Penal Code.

This order shall come into force with effect from 00:00 hrs. on 04.05.2020 and shall remain in force till further orders.

In view of the emergent nature of the order, it is being issued Ex-parte and is addressed to the public in general.

This order shall be promulgated by affixing copy thereof at the notice boards of the Office of District Magistrate, Chandigarh and publication in the news paper having circulation in the area, through the office of D.P.R. Chandigarh.
