**ORDER**

Whereas, the entire operational area of Gram Panchayats i.e. Majra, Misserwala, Puruwala, Pipliwala, Haripurkhol and Palhodi Development Block Paonta Sahib, District Sirmaur was cordoned off vide order No. 151509 dated 09-04-2020 due to the visit of 14 Markaz Jammatees in some areas of these Gram Panchayats on 11.03.2020 and thereafter.

Whereas, the Gram Panchayats i.e. Majra, Misserwala, Puruwala, Pipliwala & Palhodi was kept out of the Hotspot/ Containment Zone vide order dated 28.04.2020 as no movement of the Jammatees in these Gram Panchayats after **23-03-2020** was found and all the primary and secondary contacts were followed up for 28 days.

Whereas, in Gram Panchayat Haripurkhol, Development Block, Paonta Sahib the last confirmed test was isolated on **04-04-2020**. Also, the Chief Medical Officer, District Sirmaur vide his report dated 06.05.2020 informed that no positive case of COVID-19 has been reported till date from the area of Gram Panchayat, Haripurkhol, Development Block, Paonta Sahib.

Whereas, as per the guidelines of the Ministry of Health & Family Welfare, Govt. of India regarding containment zone, the operation will be scaled down if no secondary laboratory confirmed COVID-19 case is reported from the geographic quarantine zone for at least four weeks after the last confirmed test has been isolated and all his contacts have been followed up for 28 days.

Therefore, I am satisfied that area of Gram Panchayat, Haripurkhol, Development Block, Paonta Sahib does not require to be continuing under Hotspot/Containment Zone. Hence, by modifying order dated 28.04.2020 partially, the following orders/directions are hereby issued:-

1. As the Gram Panchayat, Haripurkhol falls in rural area, therefore, all shops registered under H.P. Shops and Commercial Establishments Act, 1969 except those in shopping malls shall be permitted to open on daily basis (**except Sunday**) w.e.f. 09:00 A.M. to 02:00 P.M. during curfew relaxation hours. All shopkeepers shall deploy 50% strength of workers with masks and maintain social distancing norms. However, timings as mentioned above shall not apply to vegetables and fruit shops, Dairy Shops, fair price shops, bakery units, standalone shops selling essential items and liquor vends subject to the

condition that owners of these shops/vends shall ensure social distancing norms strictly.

2. The shop keepers shall make permanent markings on the ground inside the shop/stores and in the waiting area outside shop at a distance of at least 1 meter from each other and enforced social distancing.

3. Hair cutting saloons, Barber Shops, Beauty Parlours, Spas shall remain closed till further orders.

4. The shops selling liquor shall be allowed to open. However, Ahta shall not be allowed to open.

5. The Dhabas, Halwai/Sweet shops shall be permitted to open during curfew relaxation hours i.e. 09:00 AM to 02:00 PM with adequate provision for social distancing.

6. The restaurants shall be permitted to operate only for takeaway, counter sales of food items during curfew relaxation hours i.e. 09:00 AM to 02:00 PM subject to the condition that norms of social distancing by wearing masks shall be strictly followed both by the owner/workers of the restaurants and customers. However, no eating & service would be permitted. Further, Bar shall not be allowed to open.

The orders dated 03.05.2020 and 04.05.2020 and other orders issued from time to time by this office to contain Covid-19 shall remain enforced.

Any person contravening these orders shall be liable for prosecution under Section 269,270 and 188 IPC.

This order shall come into effect immediately from the date of issuance and shall remain enforced till further orders.


