## OFFICE OF THE DISTRICT MAGISTRATE KINNAUR AT RECKONG PEO DISTRICT KINNAUR

**ORDER** 

Whereas for containment of the spread of COVID19, order under section 144 of the Criminal Procedure Code & HP Epidemic Diseases COVID19 Regulation,2020 was issued on 24-03-20 vide which various restrictions on the movement of the people were imposed and also various measures were taken to ensure social distancing in accordance with the guidelines issued by the Chairperson National Executive Committee (NDMA) and Chairman State Executive Committee (HPSDMA) from time to time.

Whereas the Chairperson National Executive Committee vide order dated Ist,May,2020 has ordered the extension of Lockdown for a period of 2 weeks which will come into effect from 04-05-2020 and has further issued revised guidelines on lockdown measures.

Whereas the Chairman State Executive Committee Himachal Pradesh Disaster Management Authority vide order dated 2<sup>nd</sup> May 2020 has issued directions for strict implementation of the revised guidelines on lockdown measures issued by the Chairperson National Executive Committee with the following directions

- i) All the district will have curfew relaxation of not more the 5 hours in a day. The exact timings will be determined and notified by the each District Magistrate for the District.
- ii) Each District Magistrate will regulate opening of shops in the District in a manner that social distancing and other preventive measures can be enforced. The timings of shops would however be limited to relaxation in curfew hours except for pharmacies
- iii) Barbers shops, hair salons, spas will not be opened till further order.
- iv) Dhabas and Halwai /Sweet Shops would be allowed to open subject to compliance with all social distancing and other safety norms. Similarly restaurants would be

allowed to operate only for take away food. No eating and service would be permitted.

- v) Government offices will operate as per orders issued separately by Department of personnel, Government of Himachal Pradesh.
- vi) Interstate, inter & intra District plying of buses will continue to be prohibited till further orders.

Whereas, in view of the above and in exercise of the powers conferred in me under section 144 of the Criminal Procedure Code and Himachal Pradesh Epidemic diseases COVID 19 Regulation 2020, I Gopal Chand District Magistrate Kinnaur in partial modification of the order dated 24-03-20 hereby order the following relaxation in the territorial jurisdiction of the District Kinnaur subject to the strict observance of social distancing norms and guidelines issued vide aforesaid order of the Chairperson National Executive Committee dated 1st May,2020

- i) Timings of opening of the shops (except pharmacies& medical shops/ stores) in the District will be 10 AM to 3 PM
- ii) Liquor Vends (shops) will remain open between 10 AM to 3 PM
- iii) Barbers shops, hair salons, spas will not be opened till further order.
- iv) Dhabas & Halwai/sweets shops will be opened between 10 AM to 3 PM subject to compliance with all social distancing & other safety norms
- v) Restaurants will be allowed to operate only for take away food. No eating & service will be allowed.
- vi) Plying of intra district private vehicles and taxis will be allowed on odd and even basis. The vehicle having registration number ending in odd number will ply on odd days and vehicles

ending in even number will ply on even days. Provided further that the number of persons travelling in these vehicles will be strictly in accordance with the guidelines issued by the Chairperson National Executive committee on Ist,May,2020. However odd even policy will not apply on goods transport vehicles, vehicles engaged in essential services, ambulances and government vehicles.

- vii) For inter district Movement pass will be required.
- viii) There will be no movement of individuals for non essential activities between 7.00 PM to 7.00AM
- ix) All persons above 65 years of age and persons with co-morbidities, pregnant women and children below the age of 10 years shall stay at home except for meeting essential requirements and for health purposes as per national directives.
- x) All the shops will remain closed on every Sunday.

This order shall come into force with effect from 4<sup>th</sup> May 2020.
