## **ORDER**

## Addendum to this office memo no.COVID-19/864-85 dated 02.06.2020

In pursuance of Order No. DMC-SPO-2020/6123 dated 30.05.2020 of Haryana State Disaster Management Authority issued by Chief Secretary cum Chairperson Haryana State Executive Committee vide which issue an order to extend the lockdown in containment zones upto 30.06.2020, and re-open prohibited activities in a phased manner in areas outside containment zones and in exercise of powers conferred under section 30(2)(iv) of the Disaster Management Act, 2005, the following is hereby order with immediate effect for strict compliance by all concerned with in territorial jurisdiction of district charkha dadri.

Shops of all goods & services are allowed to open daily (Monday to Saturday) between 09:00 AM to 05:00 PM.

## Note:-

- i. Wearing of masks/face cover is compulsory both for the shopkeepers and the customers.
- ii. Social-distancing norms shall be followed for which marking at 6 ft. gap be done in front of every shop.
- iii. Hand-Sanitization must be available at the shop.
- iv. Shops counters/desks/chairs should be sanitized twice daily.
- v. There shall be no parking of vehicles in front of the shops.
- vi. No shop-keeper will put any products/items/objects outside his shop.
- vii. All shops, except medical halls and milk/dairy shops, shall remain closed on Sunday.
- viii. There shall not be more than five persons in any shop (including shopkeeper and helpers) at any point of time.
- ix. It shall be responsibility of the shopkeeper concerned to ensure compliance of above instructions. Any contravention will lead to cancellation of permission without notice.
- x. Spitting in any public place is an offence and shall be punishable under appropriate law.

Sub Divisional Magistrate concerned shall be Nodal Officer to regulate the crowd in markets. Also, maintenance of social distancing in the markets shall be ensured. Further it should be ensured that no shop runs without turn and action shall be taken against the violators.
