**S.O. 31 dated -19<sup>th</sup> June, 2020--**In exercise of the powers conferred by Section 29 of the Jharkhand Tax on Professions, Trades, Calling and Employment Act, 2011 (Jharkhand Act 02, 2012), the Governor of Jharkhand is pleased to make the following amendments in the Schedule appended to the Act :-

**Amendments**

1. In the Schedule appended to the Jharkhand Tax on Professions, Trades, Calling and Employment Act, 2011, after Entry No. 8, a new Entry No. 8A shall be added/ inserted in the following manner :-
