The 22nd August, 2020

No. Leg. 25/2020.—The following Ordinance of the Governor of Haryana promulgated under clause (1) of article 213 of the Constitution of India, on the 23rd July, 2020 and the President of India approved the promulgation of the said Ordinance by the Governor of Haryana vide order dated 1st August, 2020 and is hereby published for general information:-

HARYANA ORDINANCE NO. 9 OF 2020

THE FACTORIES (HARYANA AMENDMENT) ORDINANCE, 2020

AN

ORDINANCE

further to amend the Factories Act, 1948, in its application to the State of Haryana.

Promulgated by the Governor of Haryana in the Seventy-first Year of the Republic of India.

Whereas the Legislature of the State of Haryana is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Haryana hereby promulgates the following Ordinance:-

1. This Ordinance may be called the Factories (Haryana Amendment) Ordinance, 2020.
2. After section 5 of the Factories Act, 1948, the following section shall be inserted, namely:-

Short title.

Insertion of section 5A in Central Act 63 of 1948.

“5A. Power to exempt new factories in public interest.—Where the State Government is satisfied in the public interest that it is necessary to create more economic activities and employment opportunities, it may, by notification in the Official Gazette, exempt, subject to such conditions as it may think fit, any new factory or class or description of new factories which are established and whose commercial production start, from all or any of the provisions of this Act for a period of one thousand days from the date on which such commercial production start.

Explanation.—For the purposes of this section, the expression “new factory or class or description of new factories” means such factory or class or description of factories which are established and whose commercial production start within a period of one thousand days from the commencement of this Ordinance.”
