OFFICE ORDER

Subject: Approval of revised layout/ building plans.

Consequent upon the directions issued by HARERA, Gurugram, not to approve any additions and alterations in the already sanctioned plans/ layout plans / specification of the building/ common area within the project, without the previous written consent of at least 2/3rd of the allottees, it is hereby ordered that no revision of layout plan or building plans shall be allowed without meeting the requirement of Section 14 of HARERA Act.

- 2. In future, on submission of revised building plans the same will be examined by the Building Plan Approval Committee (BPAC) and if found in order, the BPAC shall grant in-principle approval with the condition that the applicant shall submit the consent of 2/3rd allottees before issue of grant of final approval (BR-III). In the event of the applicant/ colonizer failing to submit the consent of 2/3rd allottees the revised building plans will be rejected.
- 3. However, the cases which are in pipeline, i.e., where the BPAC has already approved the plans in-principle, for inviting objections/suggestions under the prevailing policy dated 28.01.2013 and practices the same shall be allowed to be approved as per present practice and approval letter may be issued in such cases.
- 4. The cases pertaining to revision of layout plan, either upon grant of additional licence or otherwise, shall also be examined/ considered on the same principle as indicated at para no. 2 and 3 above, except that the in-principle approval/ final approval shall be at the level of Director.

These interim orders shall be followed in letter and spirit till a final decision on the matter is taken at the level of State Government based on detailed deliberations, for which a separate file stands submitted.
