## Addendum I to DGS Order 37 of 2020 dated 10.11.2020

## Subject – <u>Non-levy of penalty for Correction in the Seafarer Data – Extension of date</u> w.r.t. DGS Order No. 37 of 2020

Whereas the Directorate vide Training Circular 08 of 2019 dated 30.04.2019, has given the responsibility of generation of INDOS number to MTIs for the candidates. Further to ensure the correctness of Seafarer data, the Directorate vide para 10.2 of the same Circular has stated that in case of any errors / corrections in the submitted data (batch detail etc.), the MTI shall directly send email to INDOS cell requesting for corrections to be made with attached scan copy of Passport. The MTI shall be penalized and charged Rs. 3000 /- for each correction.

2. The Directorate vide DGS Order No. 37 of 2020 dated 10.11.2020 has made a partial modification to the above circular by relaxing the provision of fine of Rs.3000/- for the period of three months from 10.11.2020 to 09.02.2021.

3. The MTIs are conducting courses through Virtual Classes/Live video sessions for conduct of exit examination for seafarers. Hence, it is not possible for the MTIs to physically verify the details of the candidates. Taking cognizance of the Pandemic situation, the Directorate has decided to relax the condition further.

4. In view of this, the partial modification to Training Circular No. 8 of 2019 dated 30.04.2019 for non-imposing of fine of Rs.3000/- on MTI will further be extended for a period of another three months from 10.02.2021 to 09.05.2021.
