NOTIFICATION

In exercise of the powers conferred by section 4 read with section 10 of the Karnataka Epidemic Diseases Act, 2020 (Karnataka Act 26 of 2020) and in partial modification of earlier regulations or orders issued in this behalf to enforce COVID-19 appropriate behavior in public places like wearing mask, maintenances of social distance, restriction in the number of participants in gatherings, limiting the scope of certain activities etc., the Government of Karnataka hereby makes the following Order, namely:-

ORDER

The General Public who violates to follow the Regulations / guidelines as specified in column (2) of the table below and rules issued in this behalf, the Compounding amount for violation of Regulations or guidelines and rules issued in this behalf shall be as specified in column (3) there of and the Public Servant or Officers or Officials authorised to compound the offences shall be as specified in column (4), thereof,-

(iv) Cremation or burial: 50 persons. (v) Other functions: 100 persons.
