No. DM/MA/2021/6098.—Whereas, the country is at critical juncture in its fight against COVID-19 and the Ministry of Home Affairs, Government of India and the Chandigarh Administration has issued various guidelines from time to time to prevent/contain the spread of COVID-19.

Whereas, with a view to consolidating the substantial gains that have been achieved against the spread of COVID-19, and to fully overcome the pandemic, the need of hour is to maintain caution and strictly follow the prescribed containment strategy, focused on surveillance, containment and strict observance of the guidelines.

Whereas, the undersigned is of the opinion that more stringent measures are required to be taken to adhere to the guidelines issued by the Govt. of India from time to time in order to prevent/contain the spread of COVID-19.

Therefore, the undersigned in his capacity as the Chairperson, District Disaster Management Authority, U.T., Chandigarh, in exercise of the powers conferred under Section 30 of The Disaster Management Act, 2005 hereby order that **all restaurants/eating places, hotels including food joints/courts in various malls falling within the jurisdiction of Chandigarh shall run only with 50% of their capacity and shall close by 11:00 P.M. The last order can be taken till 10:00 P.M.**

The Sub-Divisional Magistrates of the concerned sub-division shall ensure proper implementation of this order through the Incident Commanders and other agencies such as Police, Health, etc. of the Chandigarh Administration.

Any breach of this order will attract strict action under the provisions of the Disaster Management Act, 2005 and under section 188 of the Indian Penal Code, 1860.

This order shall come into force with immediate effect and shall remain valid till further orders.
