Epidemic Diseases Act, 1897. No.GP/13/NCV/102020/SF-1/G:-WHEREAS the State Government had, under the powers conferred by sections 2, 3 and 4 of the Epidemic Diseases Act, 1897 (3 of 1897) framed the Gujarat Epidemic Diseases, COVID-19 Regulations, 2020 vide Government Notification, Health and Family Welfare Department No._GP/9/NCV/102020/SF-1/G, dated the 13th March, 2020;

AND WHEREAS the number of COVID-19 cases in the State of Gujarat appears to have continued to increase over the past few days;

AND WHEREAS there is a need to extend the period of Gujarat Epidemic Diseases, COVID-19 Regulations, 2020;

AND WHEREAS to control over the spread of disease in the State of Gujarat the State Government decided to extend the period of Gujarat Epidemic Diseases, COVID-19 Regulations, 2020;

NOW, THEREFORE, in exercise of the powers conferred by sections 2, 3 and 4 of the Epidemic Diseases Act, 1897 (3 of 1897), the Government of Gujarat hereby amends the Gujarat Epidemic Diseases, COVID-19 Regulations, 2020, as follows:-

In the said notification, in regulation no. 1, in clause (ii), for the words "and shall remain in force for the period of one year from the date of its publication", the words, figures and letter "and shall remain in force on and from the 13th March, 2021 to 31st December, 2021", shall be substituted.

The remaining conditions of the said notification shall be unchanged.
