

following limits are already prohibited in terms or Order No. 8/8/2020-MAG/L&O/(VOL-II)/892 dated 07-04-2021 issued under section 144 of the Code of Criminal Procedure of 1973;

1) For hall of maximum capacity upto 100, gathering upto maximum of 50% of the hall capacity or a maximum of 50 person whichever is lower, and

2) For halls with capacity of more than 100, gathering will be permissible upto 50% of its capacity or maximum of 100 persons, whichever is lower and;

3) For open premises and grounds gathering upto 50% of its capacity or maximum gathering of people upto 200 persons, whichever is lower.

Other statutory permissions have to be sought by the applicants in addition to this permission.

The organizer as well as the venue in-charge shall be held responsible for any violation of this order. The organizer and the venue in-charge shall also ensure wearing of masks, norms of social distancing and other Covid appropriate behavior. Any person contravening this order shall be liable to be proceeded against as per the provision or section 51 to 60 of the Disaster Management Act, 2005 besides legal action under section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte.

This order shall come into force from 00.00 hrs. of 18-04-2021 in continuation of the Order No. 8/8/2020-MAG/L&O/(VOL-II)/892 dated 07-04-2021.

Any Central or State Government functions shall be exempted from the permission as above.

**Micro-Containment Order**

No. 50-134/COLL(N)/DMC/CONT-SDM/  
/2020-21/526

Whereas, there is a prevailing situation in the country due to the Health Emergency posed by

COVID-19, an infectious disease caused by Corona Virus;

Whereas, it has been made to appear to the undersigned by the Health Officer, Urban Health Centre, Mapusa, that there is a need for declaration of below mentioned areas Bardez Taluka as Micro-Containment Zone in North Goa District being vulnerable to the spread of the disease;

Now, therefore, in exercise of the powers conferred upon me under Section 30 and Section 34 of the Disaster Management Act, 2005 and under provisions of Epidemic Diseases Act, 1897 read with "The Goa Epidemic Disease COVID-19 Regulation, 2020", I, Ajit Roy, IAS, District Magistrate, North Goa do hereby declare area given below, as Micro-Containment Zones for all purpose and objectives prescribed in the protocol of COVID-19 to prevent its spread in the adjoining areas;

**Micro-Containment Zone**

For combating the situation at hand, the following action plan is prescribed to be carried out including screening, testing of suspected cases, quarantine, isolation, social distancing and other public health measures in the Micro-Containment Zone effectively:

1. *Deployment of Rapid Response Team (RRT)*

The Rapid Response Team is to investigate the outbreak and initiate control measure by assessing the situation.

**Members of Rapid Response Team for Bardez Taluka**

1. The Dy. Collector & SDM-II, Bardez Taluka (In-charge).
2. The Superintendent of Police, Porvorim.
3. The Health Officer, Urban Health Centre, Mapusa.
4. The Chief Officer, MMC, Bardez-Goa.
5. The Fire Station Officer, Panaji, Department of Fire & Emergency Services.
6. The Mamlatdar, Bardez Taluka.
7. The Inspector of Civil Supply Department, Mapusa.

(Action: Dy. Collector & SDO-II, Bardez)

2. *Screening of Persons*

Health Check-up of sick persons of above area through mobile check-up vans is to be carried out. The list of person found sick marked with red ink is to be prepared so that further necessary action is taken. All positive cases are to be shifted to Covid Care Centre or Covid hospital for further management as required. The Health Officer, Urban Health Centre, Bardez, Goa is to ensure screening/testing of all the close contacts as per medical protocol and contact tracing of all persons who have come in contact with these persons.

(Action: Health Officer, Mapusa)

3. *Uninterrupted Power Supply*

Regular power supply in the Micro-Containment Zone shall be ensured by Executive Engineer, O/o. Executive Engineer, Electricity Dept., Mapusa.

(Action: Electricity Department)

4. *Uninterrupted Drinking Water Supply*

Regular safe drinking water supply shall be ensured by the Executive Engineer, Division-III, PWD, Bardez.

(Action: PWD)

5. *Uninterrupted Telecom Services*

Regular telecom services shall be ensured by BSNL, Panaji.

(Action: BSNL, Panaji)

6. *In the Micro-Containment Zone, the following activities shall be undertaken by the local authorities:*

- a) Contact Tracing.
- b) Home or Institutional Quarantining of individuals based on risk assessment by medical officers. This risk assessment will be based on symptoms, contact with confirmed cases and travel history.
- c) House to house surveillance by special teams constituted for this purpose.
- d) Counseling and educating people and establishing effective communication strategies.

(Action: Health Officer, Mapusa)

7. *Line Departments with specific responsibility:*

1. Police Department in managing Law & Order through Strict Vigil.
2. Fire Department in Sanitizing/Disinfecting Area as and when required.

(Action: Dy. Collector & SDO-II, Bardez)

Any violation shall invite criminal proceedings under the relevant provisions of the Disaster Management Act, 2005 and the Indian Penal Code, 1860.

The Sub-Divisional Magistrate-II, Bardez shall be overall-in-charge of the Micro-Containment Zone and Buffer Zone and over-see all the arrangements.

All the Officers/officials on duty shall perform/discharge their duties efficiently and any laxity on the part of any Officer/official will attract strict action under the provisions of Disaster Management Act, 2005.
