1973 to take preventive steps to contain the spread of Virus by restricting public gatherings and activities;

And whereas, in am satisfied that the circumstances do not permit the serving, in due time, of the notices individually upon the persons against whom this order is directed and therefore, under the powers vested in me under sub-section (2) of Section 144 of the Code of Criminal Procedure, 1973, I hereby pass the order ex-parte;

Now, therefore, I, Ajit Roy, IAS, District Magistrate, North Goa District, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973, direct that the following activities shall be prohibited or restricted in the District of North Goa, till further orders:

1. No shops/establishments to remain open between 10 pm. to 6 am. except industries/factories and other essential offices/utilities such as Government offices and PSUs, local bodies, medical and health facilities, chemists, groceries/eatables, restaurant kitchen, hotels, public and private transports, Print and Electronic media, Telecommunication and Internet services, banks, insurance, ATMs, Petrol Pumps, LPG cylinder services.

2. The following establishments may run, but with less than 50% capacity.

- a. bars/restaurants,
- b. river cruises/waterparks/entertainment parks,
- c. gym/spa/massage parlours,
- d. cinema halls, theatres, multiplexes,
- e. casinos,
- f. buses used as public transport.

3. The following establishment/facilities/events shall remain closed till further order.

- a. swimming pool,
- b. schools, Colleges, educational and coaching institutions, except for examinations of college students,
- c. religious places for the public, however the custodian of such establishments may carry out regular activities.
- d. social/political/sports/entertainment/ academic/cultural functions and other congregations, except for, events with the permission of the government, marriages with 50 with permission from DM/SDM or less people and cremation with less than 20 people,

e. gathering of five or more persons at public places, except for official functions or with permission from DM/SDM.

All non-government employers are also advised to actively plan for and promote work from home for the employees working in their shops/ /establishments/factories.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code and Section 51 to 60 of the Disaster Management Act, 2005.

This order comes into force from 00:00 hrs. of 22 April, 2021 (intervening midnight of 21st and 22nd April, 2021).

This Order supersedes the Order No. 8/8/2021--MAG/L&O(Vol.II)/962 dated 17-4-2021 and Order No. 8/8/2021-MAG/L&O(Vol. II)/892 dated 07-4-2021.

Whereas, a fresh surge in COVID-19 cases is being witnessed in Goa as well as some parts of the country, and the situation might further aggravate due to religious/sports/entertainment/educational/ cultural or any other form of gatherings,

And whereas, in order to contain the spread or the said pandemic, certain measures are required to be taken to prevent the spread of the disease.

And whereas, in my considered opinion, there is sufficient grounds for proceeding under sub-section (1) of Section 144 of Code of Criminal Procedure, 1973 to take preventive steps to contain the spread or Virus.

Now therefore, I, Ajit Roy, IAS, District Magistrate, North Goa District, in exercise of the power vested in me under sub-section (1) or the section 144 of Code of Criminal Procedure, 1973, and in continuation of the Order No. 8/8/2020-MAG/L&O/ (VOL-II)/892 dated 07-04-2021 do hereby direct that any gatherings of more than 50 persons shall not be allowed in the jurisdictions of North Goa without the prior written permission of the Sub-District Magistrate concerned. Any gathering beyond the

following limits are already prohibited in terms or Order No. 8/8/2020-MAG/L&O/(VOL-II)/892 dated 07-04-2021 issued under section 144 of the Code of Criminal Procedure of 1973;

1) For hall of maximum capacity upto 100, gathering upto maximum of 50% of the hall capacity or a maximum or 50 person whichever is lower, and

2) For halls with capacity of more than 100, gathering will be permissible upto 50(% of its capacity or maximum of 100 persons, whichever is lower and;

3) For open premises and grounds gathering upto 50% of its capacity or maximum gathering of people upto 200 persons, whichever is lower.

Other statutory permissions have to be sought by the applicants in addition to this permission.

The organizer as well as the venue in-charge shall be held responsible for any violation of this order. The organizer and the venue in-charge shall also ensure wearing of masks, norms of social distancing and other Covid appropriate behavior. Any person contravening this order shall be liable to be proceeded against as per the provision or section 51 to 60 of the Disaster Management Act, 2005 besides legal action under section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte.

This order shall come into force from 00.00 hrs. of 18-04-2021 in continuation of the Order No. 8/8//2020-MAC/L&O/VOL-II)/892 dated 07-04-2021.

Any Central or State Government functions shall be exempted from the permission as above.

Now, therefore, in exercise of the powers conferred upon me under Section 30 and Section 34 of the Disaster Management Act, 2005 and under provisions of Epidemic Diseases Act, 1897 read with "The Goa Epidemic Disease COVID-19 Regulation, 2020", I, Ajit Roy, IAS, District Magistrate, North Goa do hereby declare area given below, as Micro-Containment Zones for all purpose and objectives prescribed in the protocol of COVID-19 to prevent its spread in the adjoining areas;
