Whereas, the General Manager, GSIDC, Panaji vide letter referred at Sr. No. (1) & (2) has informed that the contractor M/s. Larsen & Tourbo has requested traffic diversion on the Ponda side ramp of Atal Setu to undertake work of repairing of ramp on left hand side of Atal Setu at Merces Junction for a period of 03 months from 15th April, 2021 to 15th July, 2021 and to carry out work of overlaying/ /hotmixing works from Pundalik Nagar Circle Porvorim to Mandovi Bridges from 25th April, 2021 to 31st May, 2021.

And whereas, as discussed in the meeting held on 27-04-2021 with the Dy. Collector & SDM, Panaji, DYSP Traffic (N), Altinho, PWD, Panaji and GSIDC, Panaji it is decided to recommend GSIDC to carry out the work of only hotmixing and minor works from Pundalik Nagar Circle, Porvorim to Malim Junction in consultation with DYSP Traffic (N), Altinho from 29th April, 2021 to 9th May, 2021.

Now therefore, in exercise of the powers conferred on me under Sections 115 & 116 of the Motor Vehicles Act, 1988, and as recommended by the Dy. Superintendent of Police (Traffic), Altinho, Panaji and Executive Engineer, WD-VII (NH), PWD, Panaji, I, Ajit Roy, IAS, District Magistrate, North Goa hereby order the work of only hotmixing and minor works from Pundalik Nagar Circle, Porvorim to Malim Junction in consultation with DYSP Traffic (N), Altinho from 29th April, 2021 to 16th May, 2021.

Once the ongoing work of PWD is completed from Merces to KTCL, Bus Stand and the traffic is released rigid pavement, the GSIDC shall start the work of repairing the ramp on left hand side of Atal Setu at Merces Junction and divert the vehicular traffic on the Ponda side ramp of Atal Setu in consultation with DYSP Traffic (N), Panaji.

The ongoing work of PWD and the two proposals of GSIDC, Panaji shall be completed by 31-05-2021 positively.

The Managing Director, Goa State Infrastructure Development Corporation Limited, Panaji is directed to publish this Order through the Director of Information and Publicity in press/media/social media regarding the traffic diversion and to make necessary arrangements to erect the signboards at the required places and report compliance within fifteen days time.

Conditions

- 1. The GSIDC/Contractor is directed to erect sufficient traffic signages/directional boards regarding closure at diversion points for the information of motorists and other road users.
- 2. The GSIDC/Contractor is directed to give notice through Press/Media regarding closure and diversion of the road on receipt of this Order for the information of the motorists and other road users.

- 4. Prior permission from other competent authorities should be obtained in advance.
- 5. NOC from concerned Police Station should be obtained.
- 6. Material used for barricading the road should be painted/pasted with fluorescent paint/tape for illuminating the same during the night time.
- 7. Material used for barricading of road should be removed immediately and the road should be thrown open for vehicular flow after resurfacing the same.
- 8. The work should be completed on or before 31-05-2021.
- 9. The contact number of the Contractor/ /Supervisor or the responsible person should be displayed at all closure/diversion points so as to enable him/her to contact if any emergent situation arises.
- 10. This permission is subject to cancellation/ /revocation at any moment.
