## **ORDER**

Whereas, an order bearing no. DM/MA/2021/12485, dated: 09.06.2021 was issued by the office of the undersigned whereby Corona Curfew has been imposed in Chandigarh between 10:00 P.M. to 05:00 A.M. on all days, as a measure of isolation and social distancing to contain the spread of COVID-19 due to a lot of non-essential movement of people and vehicles.

Whereas a War Room meeting was held on 08.06.2021 to review the COVID-19 situation in Chandigarh. In the said meeting, it was decided that there will be a total closure on Sunday.

Now, therefore, I, Mandip Singh Brar, I.A.S., District Magistrate, U.T., Chandigarh, while exercising the power vested with me u/s 144 Cr.P.C. do hereby order that there shall be a Corona Curfew from 05:00 A.M. on Sunday, dated: 13.06.2021 till 05:00 A.M. on Monday, dated: 14.06.2021 in U.T., Chandigarh. No person shall leave their home or shall move on foot or by vehicle or travel or stand or roam around on any road or public places during above said hours.

Following categories shall be exempted:

- Those tasked with law & order/emergency and municipal services/duties including Executive Magistrates, Police personnel, Military/C.A.P.F. personnel in uniform, health, electricity, fire, media persons with accreditation, telecom services including internet, Govt. postal services, banking and Government machinery tasked with COVID-19 related duties (all on production of Identity Card).
- 2. The manufacturing units/industry shall be allowed to remain open. The movement of employees/labour of manufacturing unit/industry and vehicles carrying them shall be allowed. However, concerned unit/industry shall issue them requisite permission/identity cards for the purpose and details of the same shall be shared with the Director, Industries, Chandigarh.
- The shops dealing with supply of essential goods like milk, bread, vegetables, fruits, dairy products, eggs, meat, groceries, bakeries, etc. shall be allowed to remain open only for home delivery up-to 02:00 PM.
- There shall be no curbs on inter-State movement of essential and non-essential goods.
- All vehicles/persons in bonafide inter-State transit shall be allowed to pass, but only after due verification of point of origin and destination.
- 6. A.T.M., Hospitals, Veterinary Hospitals and all related medical establishments, including their manufacturing and distribution units, both in public and private sector, such as dispensaries, chemist, pharmacies and medical equipment shops, laboratories, pharmaceutical research labs, clinics, nursing homes, ambulance, etc. will continue to remain functional. The transportation for all medical personnel, nurses, para-medical staff, other hospital support services shall be permitted.
- 7. The kitchens of restaurants/eating places, hotels including food joints/courts in various malls can remain open for home delivery only up-to 10:00 P.M. Their staff shall be

allowed to move on production of valid I.D. card issued to them by the respective establishment.

- 8. The barber shop shall be allowed to remain open till 02:00P.M.
- 9. Pregnant women and patients for getting medical/health services.
- 10. Passengers going to or returning from the airport or railway station or I.S.B.T. shall be exempted.
- 11. Marriages with prior permission from S.D.M. concerned with attendance of up-to 30 persons shall be allowed. Funerals/last rites with attendance of up-to 30 persons are allowed.
- 12. During the Corona Curfew period, those going for appearing in examination and those on examination duties will be allowed movement on production of admit/identity cards.
- 13. Those specially issued a restricted movement pass by the officers authorized in this behalf. Persons seeking movement pass may contact at 0172-2700076 & 0172-2700341 or apply online on <a href="www.admser.chd.nic.in/dpc">www.admser.chd.nic.in/dpc</a>. Sh. Pardhuman Singh, H.C.S. and Sh. Sanjeev Kohli, R.L.O. will be the Nodal Officers for this purpose.
- 14. Those Govt. employees working in tricity shall be allowed transit on production of valid identity cards and duty orders.
- 15. All vaccination centres/testing centres/dispensaries/medical facilities shall remain open.
- 16. Morning walk shall be allowed from 06:00 A.M. to 09:00 A.M. However, the public shall strictly maintain COVID protocols, i.e. wearing of mask, social distancing, etc.
- 17. All passes related to the Hon'ble Punjab and Haryana High Court and District Court shall be issued by the Registrar General, Punjab & Haryana High Court.

Any breach of this order shall invite action under section 188 of the Indian Penal Code.

This order shall come into force with immediate effect and shall remain in force till the above specified date and time.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general.

This order shall be promulgated by affixing copies thereof at the notice boards of the office of the undersigned as well as District Courts and publication in the newspapers having circulation in the area, through the office of the D.P.R., Chandigarh.
