## **ORDER**

No.13180-HIII(5)/2021/9611 Dated 13/07/2021

Further to Order No.13180-HIII(5)/2021/9215, dated 06/07/2021, it is hereby ordered as under:-

- The schools will start functioning physically from 19th July, 2021 for 9<sup>th</sup> to 12<sup>th</sup> classes subject to parents' consent for sending their wards to the schools. However, online mode of teaching will continue. Detailed order in this behalf will be issued by Secretary, Education.
- The coaching institutes will be allowed to function physically from 19th July, 2021 with the condition that all the eligible students and staff are administered at least one dose of vaccine and the covid protocols are strictly followed in the institutes. Detailed order in this behalf will be issued by Secretary, Education.
- 3. The number of guests for social gatherings like weddings would be increased from 100 to 200 or 50% capacity of the banquet halls, whichever is less with the condition that all adult guests and staff of the hotels/banquet halls must have received at least one dose of vaccine or have negative RT-PCR report of last 72 hours.
- Rock Garden and Museums will be opened with covid protocol.
- Cinema halls and Spas would also be allowed to function with 50% capacity.

The instructions from serial No.3 to 5 shall come into force with effect from 14/07/2021 and those at serial No.1 and 2 with effect from 19/07/2021 and will be applicable until further orders.

Any breach of this order shall invite action under Section 51 to 60 of the Disaster Management Act, 2005 and Section 188 of the Indian Penal Code along with other applicable laws.
