ORDER:

In the Government Order first read above, the minimum rates of wages for the Employment in Leather goods manufactory were revised under the provisions of the Minimum Wages Act, 1948 (Central Act XI of 1948). The Government have now proposed to further revise the minimum rates of wages for the above said employment.

2. The appended Notification will, accordingly, be published in the Tamil Nadu Government Gazette both in English and Tamil. APPENDIX. NOTIFICATION.

The following draft Notification, which is proposed to be issued in exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948), is hereby published for information of all persons likely to be affected thereby, as required by clause (b) of sub-section (1) of section 5 of the said Act.

2. Notice is hereby given that the draft Notification will be taken into consideration on or after the expiry of two months from the date of publication of this Notification in the <u>Tamil Nadu Government Gazette</u> and that any objection or suggestion, which may be received from any person with respect thereto before the expiry of the aforesaid period will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Secretary to Government, Labour Welfare and Skill Development Department, Secretariat, Chennai - 600 009 through the Commissioner of Labour, Chennai - 600 006.

DRAFT NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No. II(2)/LE/479/2014, published at page 537 of Part II - Section 2 of the <u>Tamil Nadu Government Gazette</u>, dated the 13th August 2014, the Governor of Tamil Nadu, hereby revises the minimum rates of wages payable to the classes of employees in the Employment in Leather goods manufactory in the State of Tamil Nadu specified in column (2) of the Schedule below, as specified in the corresponding entries in column (3) thereof.

Explanations.- (1) Zone A and Zone B shall comprise the following areas:-

Zone – A: All Municipal Corporations.

Zone - B: All areas other than Municipal Corporations.

- (2) <u>Dearness Allowance</u>.- In addition to the minimum rate of basic wages fixed above, the employees shall be paid dearness allowance as indicated below:-
 - (i) The dearness allowance is linked to the Average Chennai City Consumer Price Index for the year 2010, that is, 161 points (with base 2001=100) and for every raise of one point over and above 161 points, an increase of Rs.35.90 (Rupees thirty five and ninety paise only) per month shall be paid as dearness allowance.
 - (ii) The dearness allowance shall be calculated every month based on the availability of latest consumer price index points.
- (3) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.
- (4) To arrive at daily rates of wages, the monthly wages shall be divided by 26.
- (5) Wherever the existing wages are higher than the minimum wages fixed herein, the same shall be continued to be paid.
