Registrar of Co-operative Societies, Ponda Zone, Ponda-Goa is satisfied that no useful purpose will be served by merely continuing the existence of Mahabaleshwar Co-operative Housing Society Ltd., Prabhunagar, Ponda-Goa and hence the registration of the society stands cancelled with immediate effect.
