Whereas, Adv. Arun A. S. Talaulikar, having Office at Neurencar Photo Studio, 31st January Road, Behind Head Post office, near District Court, Panaji, Goa was appointed as Registrar's Nominee under Section 86(1) of the Goa Co-operative Societies Act, 2001 read with Rule 116(1) of the Goa Co-operative Societies Rules, 2003 vide Order read at Sr. No. 2 above.

And whereas, now vide letter read at Sr. No. 3 above a request has been received from The Asstt. Registrar of Co-op. Societies, North Zone, Mapusa

Goa to designate Adv. Arun A. S. Talaulikar as the dedicated nominee of The Azmane Urban Co-op. Credit Society Ltd., Mandur Neura, Goa to adjudicate dispute referred to him by the said society.

In view of above, the above named nominee Adv. Arun A. S. Talaulikar in exercise of powers conferred under Section 123(B) of the Goa Co-op. Societies Act, 2001, I, the undersigned hereby authorize the above named nominee to entertain the disputes referred to him on recovery of loan overdues matter by The Azmane Urban Co-op. Credit Society Ltd., Mandur Neura, Goa.

When a purported dispute is referred by the society, the above named nominee is authorised to first decide under sub-section (1) of Section 86 of the Goa Co-operative Societies Act whether the matter referred by society involves a dispute and pass appropriate Orders under sub-section (1) of Section 86.

Only upon the nominee satisfying that there exists a dispute he shall proceed to adjudicate the same and give award accordingly. The nominee
