AMENDMENTS TO THE ANDHRA PRADESH AIR (PREVENTION AND
CONTROL OF POLLUTION) RULES, 1982.

NOTIFICATION

In exercise of the power conferred by the Section 54 of the Air (Prevention and Control of Pollution) Act, 1981 (Act 14 of 1981), the State Government after consultation with the Andhra Pradesh Pollution Control Board, hereby make the following amendments to the Andhra Pradesh Air (Prevention and Control of Pollution) Rules, 1982, as amended from time to time and it shall come into force from the date of publication in the official Gazette:-

AMENDMENTS

In the said rules,-

1. **In Rule 2**, after item (v), the following shall be inserted, namely:-

“(w)“**Annual Compliance Statement**” means a statement to be submitted by all persons or occupiers carrying on any industry, factory, mine, operation or process and all other activities, which requires consent under the Air (Prevention and Control of Pollution) Act, 1981 or any other Acts, Rules and Notifications where the Andhra Pradesh Pollution Control Board is the

prescribed authority, including the compliance status of the conditions imposed in the consent for establishment, consent for operation, Authorizations; the compliance status on the directions issued by the Andhra Pradesh Pollution Control Board; and an overall assessment of the air quality, both within the premises and outside the premises in the surroundings.

- (x) "Environment Quality Assessment Auditor" means a person or agency or organization empanelled and notified by the Andhra Pradesh Pollution Control Board for the purposes of Environmental Quality Assessment.
- (y) "Environmental Statement" means a statement to be submitted by every person or occupier carrying on an industry, operation, or process requiring consent under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 (Act 14 of 1981) to the concerned State Pollution Control Board on or before the 30th day of September every year, as per Rule 14 of the Environment (Protection) Rules, 1986."

2. After Rule 29-A, the following shall be inserted, namely :-

"Rule 29-B: Submission of Annual Compliance Statement: -

- (1) Every person or occupier carrying on any industry, factory, mine, operation or process and all other activities, which requires consent under the provisions of the Air (Prevention and Control of Pollution) Act, 1981 shall submit Annual Compliance Statement to the Andhra Pradesh Pollution Control Board in the prescribed proforma, every year on or before the 30th day of September, along with Environmental Statement as required under Rule 14 of the Environment (Protection) Rules, 1986.
- (2) The Annual Compliance Statement and Environmental Statement submitted under sub-rule (1) shall be placed by the person or occupier on their website, as well as on the website of the Andhra Pradesh Pollution Control Board with a provision to obtain comments or remarks from any Indian resident for a minimum period of 15 days.
- (3) The Government of Andhra Pradesh in consultation with the Andhra Pradesh Pollution Control Board may prescribe a fee to be paid along with the Annual Compliance Statement to meet its expenses.
- (4) Any person or occupier who fails to submit the Annual Compliance Statement and Environmental Statements specified in clause (1) above within the prescribed time shall be liable to pay a late fee as specified by the Government of Andhra Pradesh in consultation with the Andhra Pradesh Pollution Control Board; apart from other actions under the provisions of the Air (Prevention and Control of Pollution) Act, 1981.
- (5) The Andhra Pradesh Pollution Control Board shall mandatorily take up inspections under section 24 of the Air (Prevention and Control of Pollution) Act, 1981 of any industry, factory, mine, operation or process and other activities, which fails to submit the Annual Compliance Statement and Environmental Statements specified under sub-rule (1) and take further necessary action as stipulated under provisions of the Air (Prevention and Control of Pollution) Act, 1981.

Rule 29-C: Verification of Annual Compliance Statement and Environmental Statement

- (1) The Andhra Pradesh Pollution Control Board, on its own or through the Environment Quality Assessment Auditor, shall carry out the verification of the Annual Compliance Statement and Environmental Statement submitted under sub-rule (1) of Rule 29-B along with the comments or remarks obtained as per sub-rule (2) of Rule 29-B above.
- (2) Environment Quality Assessment Auditor shall submit the verification report to the Andhra Pradesh Pollution Control Board within stipulated period as specified by the Andhra Pradesh Pollution Control Board.
- (3) In case, non-compliances or lapses are noticed by the Environment Quality Assessment Auditor or the Andhra Pradesh Pollution Control Board, the Andhra Pradesh Pollution Control Board shall inspect and take the necessary action as per the provisions of the Air (Prevention and Control of Pollution) Act, 1981.
- (4) After inspection by the Andhra Pradesh Pollution Control Board, suitable specific directions under section 31-A of the Air (Prevention and Control of Pollution) Act, 1981 may be issued to the person or occupier to rectify the non-compliances or the lapses noticed, duly specifying the timeframe for compliance of each direction.

Rule 29-D :Submission of Audited Annual Compliance Statement

- (1) The Andhra Pradesh Pollution Control Board may, after Board resolution, notify the date and notify the type of industries and activities that are required to submit audited Annual Compliance Statement and audited Environmental Statement.

Note: The Andhra Pradesh Pollution Control Board may notify different dates for different type of industries and activities that are required to submit audited Annual Compliance Statement, audited Environmental Statement.

- (2) The Annual Compliance Statement and Environmental Statement shall be audited only by an Environment Quality Assessment Auditor empanelled and notified by the Andhra Pradesh Pollution Control Board.

Rule 29-E : Empanelment of Environment Quality Assessment Auditor

- (1) The guidelines for empanelment of Environment Quality Assessment Auditors, the terms and conditions for their engagement, their powers, responsibilities and functions, action against defaulting auditors and other related matters, shall be as prescribed by Rules in this regard.
- (2) Any Environment Quality Assessment Auditor, empowered by the Andhra Pradesh Pollution Control Board, shall have a right to enter, at all reasonable times with such assistance as considers necessary, any industry, factory, mines, operation or process for the purposes of Environment Quality Assessment audit."

3. After Rule 48, the following shall be inserted, namely :-**“Rule 49:Environmental Compensation**

- (1) Whoever violates the provisions of the Air (Prevention and Control of Pollution) Act, 1981 and Rules framed there under; and causes damages to the quality of air shall be liable to pay Environmental Compensation as determined by the Andhra Pradesh Pollution Control Board in compliance of the orders of the National Green Tribunal.
- (2) The Environmental Compensation payable shall be in addition to any other actions stipulated under the Air (Prevention and Control of Pollution) Act, 1981.
- (3) In case of failure in depositing Environmental Compensation, the Andhra Pradesh Pollution Control Board shall take further action under Section 31-A of Air (Prevention and Control of Pollution) Act, 1981.

Rule 50: Online Monitoring

- (1) The Andhra Pradesh Pollution Control Board may direct under Section 31-A of Air (Prevention and Control of Pollution) Act, 1981, any person or occupier carrying on any industry, factory, mine, operation or process to
 - (i) Install online Continuous Emission Monitoring Systems; and
 - (ii) Transmit monitoring data online real time to centralized monitoring stations at the Head /Zonal /Regional Offices of the Andhra Pradesh Pollution Control Board.
- (2) If any exceedance of the pollution parameters occurs more than the standards specified, the Andhra Pradesh Pollution Control Board or its authorized agency shall communicate to the occupier and other stakeholders through electronic means or any other means for immediate corrective action by the person or the occupier.
- (3) In case of exceedances of the stipulated parameters or non-compliance of directions, the Andhra Pradesh Pollution Control Board may determine Environmental Compensation payable in accordance with the Orders of the National Green Tribunal.

Rule 51: Scientific Waste Disposal

- (1) Every person or occupier carrying on any industry, factory, mine, operation or process and all other activities which requires consent under the Air (Prevention and Control of Pollution) Act, 1981 shall ensure adequate treatment of waste and ensure scientific disposal of hazardous and other wastes through authorized agencies, as notified by the Andhra Pradesh Pollution Control Board to enable continuous waste disposal monitoring.
- (2) Any person or occupier who fails to dispose the hazardous and other wastes to the authorized agency as notified by the Andhra Pradesh Pollution Control Board shall be treated as unscientific disposal and liable for action under the Air (Prevention and Control of Pollution) Act, 1981.

- (3) Further, it shall be presumed that the hazardous and other wastes are disposed by the person or the occupier in an unauthorized manner and the person or occupier shall be liable to pay Environmental Compensation for such disposal for the entire quantity".
