Subject: Extension of validity period for six months treatment facilities/ pack houses/ ware houses/ processing units in wake of Covid -19 situation-reg.

I am directed to convey the approval of the competent authority for extending validity of treatment facilities/pack houses/warehouses/processing units registered with DPPQS as per respective National Standard for Phytosanitory Measures (NSPM)/Standard Operating Procedures (SOP) for six months whose validity is expiring from 1.4.2021 to 30.09.2021 to facilitate agriculture trade in view of present Covid-19 situation.

- 2. The following procedures are to be adopted for extension of validity
 - i. Facility/Agency/Units will submit renewal fee online at Bharatkosh.
 - ii. A request for extension of validity for six months will be sent by mail by facility/agency/unit to the renewal authority (PPA /RPQS In- Charges) as stipulated in the respective NSPM/SOP along
 - iii. Renewal Authority (PPA/RPQS In-Charges) will issue extension of validity of accreditation/registration certificate initially for six months without physical inspection.
 - iv. Facility/Agency/Unit under suspension will not be eligible for such exemption.
 - 3. Officer I/Cs of all RPQS must bring it to the notice of all stake holders and under their jurisdiction.
 - 4. Officer I/Cs of all the RPQS must send consolidated list of facilities/Agencies/units whose validity has been extended for uploading in PQIS website.
