OFFICE ORDER

Subject: Grant of Consents to Operate under the Water Act, 1974, Air Act, 1981 & Authorization under the Bio Medical Waste Management Rules, 2016 as amended from time to time to Health Care Facilities (HCFs).

In partial modification to earlier Board's office order no. 468 dated 31-08-2021, it has been decided that, HCFs upto 50 bed capacity which are discharging their liquid waste into public sewer and operating within MC limits of towns, where terminal sewage treatment plants (STPs) have been installed, shall be granted consents/authorization by Punjab Pollution Control Board (PPCB) without installation of individual ETPs, as an interim arrangement/measure, subject to the condition that HCF shall ensure to comply with the effluent standards as notified under Bio-medical Waste Management Rules, 2016 amended up to date and subsequent amendments if any.

This order shall come into force with immediate effect.
