The following draft Rules which the Government of Goa proposes to make in exercise of the powers conferred by subsection (1) of section 306 of the Goa Municipalities Act, 1968 (Goa Act No. 7 of 1969) (hereinafter referred to as the "said Act"), so as to further amend the rules specified in the Schedule hereto, framed under the said Act, are hereby pre-published as required by subsection (3) of section 306 of the said Act for information of all the persons likely to be affected thereby and notice is hereby given

that the said draft Rules will be taken into consideration by the Government after the expiry of a period of fifteen days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft rules may be forwarded to the ex officio Additional Secretary to the Government of Goa, Department of Urban Development (Municipal Administration), First Floor, Dempo Towers, EDC Patto-Plaza, Panaji-Goa, before the expiry of said period of fifteen days so that they may be taken into consideration at the time of finalization of the said draft Rules.

DRAFT RULES

In exercise of the powers conferred by subsection (1) of section 306 of the Goa Municipalities Act, 1968 (Goa Act No. 7 of 1969) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the rules as specified in the Schedule hereto framed under the said Act, namely:—

1. Short title and commencement.— (1) These rules may be called the Goa Municipalities (Amendment) Rules, 2021.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Amendment of certain Rules framed under the Goa Municipalities Act, 1968 (Act No. 7 of 1969).— In the Rules specified in the Schedule hereto, in the short title, the expression, "Daman and Diu" shall be omitted.
