No GHR/2022/75/ESI/102021/1415/M3:- In exercise of the powers conferred by sub-section (5) of section 1 of the Employees' State Insurance Act, 1948, (34 of 1948), the Government of Gujarat, in consultation with the Employees' State Insurance Corporation and with the approval of the Central Government vide Letter No. S-38025/07/2020-SS-1 dated 09.06.2021, hereby gives notice of its intension to extend the provisions of the Act to the classes of establishments specified in the schedule annexed hereto, after one month from the date of its publication in the *Official Gazette*.
