No. FW/Election,2022/ -Whereas the General Election to the Legislative Assembly of Himachal Pradesh, 2022 for which poll shall be held on the 12.11.2022(Saturday) as per letter of the Chief Electoral Officer, Haryana issued vide No. 130(Public Holiday)/HP Gen. Elec-2022/2AE-5136 dated 07.11.2022.


And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all the adult workers working in the factories situated in the State of Haryana who are the voters in aforesaid General Election to the Legislative Assembly of Himachal Pradesh is to be held on 12.11.2022 from the operations of provisions of sub-section (1) of section 52 of the said Act, for the week commencing from 13.11.2022 and ending 19.11.2022, subject to the condition that no adult worker who is enrolled as voter in aforesaid General Election to the Legislative Assembly of Himachal Pradesh shall be required or allowed to work on 12.11.2022 (Saturday) in the factories of the state of Haryana.
