**Subject: Extension in concurrent running of revised IS 16333 (Part 3): 2022**

1. These guidelines are in continuation of CMD-III's Circular of even no. dated 10 10 2022.
2. The Indian Standard for 'Mobile Phone Handsets Part 3 Indian Language Support for Mobile Phone Handsets – Specific Requirements (First Revision)' IS 16333 (Part 3): 2017 has been revised and published as IS 16333 (Part 3): 2022.
3. Considering the requests received from the Industry and the present status of implementation of IS 16333 (Part 3) : 2022 by the licensees, it has now been decided to extend the date of implementation of revised IS 16333 (Part 3) : 2022 by six months till 17 June 2023 for all applicants and licencees. Other guidelines as given in previous CMD-III circular ref: CMD-III/16: 16333 (Part 3) dated 10 October 2022 remains the same.
4. Registration Department is requested to inform the revised date of implementation of IS 16333 (Part 3) : 20022 to all Licensees/Applicants immediately and ensure implementation of revised IS 16333 (Part 3) : 2022 by **17 June 2023**.
5. The above guidelines shall come into force with immediate effect.
