In exercise of the powers conferred by section 38 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (7 of 2014), the Government of Kerala hereby make the following amendment to the Kerala Street Vendors (Protection of Livelihood, Regulation of Street Vending and Licensing) Scheme, 2019, the same having been previously



published as per notification under G. O. (P) No. 10/2019/LSGD dated 13th February, 2019 and published as S.R.O. No. 113/2019 in the Kerala Gazette Extraordinary No. 340 dated, 13th February, 2019, namely:—

SCHEME

- 1. Short title, extent and Commencement.—(1) This scheme shall be called the Kerala Street Vendors (Protection of Livelihood, Regulation of Street Vending and Licensing) Amended Scheme, 2022.
 - (2) It shall come into force at once.
- 2. Amendment of the scheme.—In the Kerala Street Vendors (Protection of Livelihood, Regulation of Street Vending and Licensing) Scheme, 2019,—
 - (a) In sub-paragraph (1) of paragraph 12,—
- (i) in the Table, in column (4), under the heading "Vending Fee" for the words "Guideline value" wherever it occurs, the words "fair value" shall be substituted;
 - (ii) after the Table, the following Explanation shall be inserted, namely:—
- "Explanation: "fair value" means fair value of land as defined under the Kerala Stamp Act, 1959 (17 of 1959)";
- (b) in Form-II, under the heading "Conditions", in Condition 8, for the words "are sold" the words "are not sold" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the notification issued under G. O. (P) No. 10/2019/LSGD dated, 13th February, 2019 and published as S.R.O. No. 113/2019 in the Kerala Gazette Extraordinary No. 340 dated 13th February, 2019, the Government of Kerala have framed the Kerala Street Vendors (Protection of Livelihood, Regulation of Street Vending and Licensing) Scheme, 2019. Sub-paragraph (1) of paragraph 12 of the said scheme provides that fixing of vending fee for the street vendors is based on the Guideline value of their vending zone. Since the Registration Department has been following fair value, the Government have decided to make suitable amendments in sub-paragraph (1) of paragraph 12 and also decided to make suitable amendments in Form-II.

The notification is intended to achieve the above objective.
