No.: GR/2023/17/ESI/102021/1415/M-3: - WHEREAS, the draft of notification was published as required by sub-section (5) of section 1 of the Employees' State Insurance Act, 1948 (34 of 1948)(hereinafter referred to as the "said Act"), at pages 70-1 to 70-2 of the Gujarat Government Gazette, Extra Ordinary, Part IV-A, dated the 19th July, 2022, under the Government Notification, Labour, Skill Development and Employment Department No: GR/2022/75/ESI/102021/1415/M-3, dated the 29th June, 2022 inviting objections or suggestions from all persons likely to be affected thereby, before the expiry of one month from the date of publication of the said notification in the *Official Gazette*;

AND WHEREAS the objections or suggestions received from the public in respect of the said draft notification, have been considered by the Government;


NOW, THEREFORE, in exercise of the powers conferred by sub-section (5) of Section 1 of the Employees' State Insurance Act, 1948, (34 of 1948), the Government of Gujarat, in consultation with the Employees' State Insurance Corporation and with the approval of the Central Government vide Letter No. S-38025/07/2020-SS-1 dated 09.06.2021, hereby extends the provisions of the said Act to the classes of establishments specified in the Schedule annexed hereto.
