- (घ) औषध (मूल्य नियंत्रण) आदेश, 2013 के 24 (4) के उपबंधा के अनुसार प्रत्येक फुटकर विकेता और वितरक विनिर्माता द्वारा दिए गए रूप में ऐसे परिसर, जहां कारबार को इस प्रकार किया जा रहा है कि उससे परामर्श के इच्छुक किसी व्यक्ति के लिए पहुंच आसान हो, वहां उसके किसी सहजदृश्य भाग पर कीमत सूची और पूरक सूची, यदि कोई हो, को संप्रदर्शित करेगा।
- (ड.) उपर्युक्त गैर अधिकतम कीमत (खुदरा मूल्य) केवल उपर्युक्त निर्माता/विपणन के लिए लागू है जैसा कि उपर्युक्त जेनेरिक/समान संरचना वाला कोई भी ब्रांड/ संबंधित विनिर्मितियों की प्रबलता तथा सरकार द्वारा निर्धारित लागू वैधानिक आवश्यकताओं की पूर्ति के अधीन प्रासंगिक विधियों/नियमों के अन्तर्गत केन्द्रीय/राज्य लाइसेसिंग ऑथोरिटी के सक्षम प्राधिकारी द्वारा मेन्यूफेक्चरिंग लाइसेंस मंजूरी के तहत संबंधित विनिर्मित निर्माता/विपणन कम्पनियां जो अनुपालन करती है।
- (च) विनिर्माता या विपणन कम्पनी, उपरोक्त विनिर्मितियों और विनिर्दिष्ट शर्तों का पालन नहीं करती हैं तो वे आवश्यक वस्तुएँ अधिनियम, 1955 के साथ पठित डीपीसीओ, 2013 के प्रावधानों के अधीन ब्याज सहित अधिप्रभारित राशि को जमा करने के लिए दायी होंगे।

**S.O. 881(E).**—In line with the directions given by the Department of Pharmaceuticals (DOP) vide review order and letter specified in column (6) of the table herein below and in exercise of the powers conferred by paragraphs 5, 11 and 15 of the Drugs (Prices Control) Order, 2013, read with S.O. 1394(E) dated the 30<sup>th</sup> May, 2013 and S. O. 5249(E) dated 11<sup>th</sup> November, 2022 issued by the Government of India in the Ministry of Chemicals and Fertilizers, and in supersession of the Order(s) of the Government of India in the Ministry of Chemicals and Fertilizers (National Pharmaceutical Pricing Authority) specified in the Column (7) of the table, the National Pharmaceutical Pricing Authority (hereinafter referred as NPPA), hereby fixes, the price as specified in column (5) of the table herein below as the retail price, exclusive of Goods and Services Tax, if any, in relation to the formulation specified in the corresponding entry in column (2) of the said Table with the strength, unit and name of manufacturer & marketing company, as specified in the corresponding entries in columns (3), (4) and (8) thereof;

- (d) As per para 24(4) of DPCO 2013, every retailer and dealer shall display price list and the supplementary price list, if any, as furnished by the manufacturer, on a conspicuous part of the premises where he carries on business in a manner so as to be easily accessible to any person wishing to consult the same.
- (e) The above mentioned retail prices are applicable only to the manufacturer / marketer as mentioned above for generic / any brand of the same composition / strength of the subject formulations, subject to fulfillment of all the applicable statutory requirements as laid down by the Govt. under relevant statutes/ rules, including manufacturing license permission from the Competent Authority i.e. the Central/State Licensing Authority, as may be applicable, by the concerned manufacturers/marketing companies.
- (f) In case the retail price of any of the aforesaid formulations is not complied with, as per instant price notification and notes specified hereinabove, then the concerned manufacturer/marketing company shall be liable to deposit the overcharged amount along with the interest thereon under the provisions of the DPCO, 2013 read with the Essential Commodities Act, 1955.
