No.G/PT/2023/4/MVD/102021/1932/KH:- WHEREAS certain draft rules were published as required by sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (59 of 1988), in the Gujarat Government Gazette, Extraordinary, Part IV-A, dated the 5th January, 2022, under the Government Notification, Ports and Transport Department No. G/PT/2022/1/MVD/102021/1932/KH, dated the 3rd January, 2022, inviting objections or suggestions from all persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the *Official Gazette*;

AND WHEREAS after careful consideration, the Government has now decided not to finalize the said draft rules and further decided to rescind the said draft notification dated the 3rd January, 2022;
